#### PRIVACY POLICY

### BACKGROUND:

Red Smoke Group Limited ("**Red Smoke**") understands that your privacy is important to you and that you care about how your personal data is used. Red Smoke respects and values the privacy of everyone who visits its website, <u>https://redsmokegroup.com</u> ("Website"). The Website will only collect and use personal data in ways that are described here, and in a way that is consistent with Red Smoke's obligations and your rights under the law.

Please read this Privacy Policy carefully and ensure that you understand it. Your acceptance of this Privacy Policy is deemed to occur upon your first use of the Website. If you do not accept and agree with this Privacy Policy, you must stop using the Website immediately.

### 1. **Definitions and Interpretation**

In this Policy the following terms shall have the following meanings:

"Cookie"	means a small text file placed on your computer or device by the Website when you visit certain parts of the Website. Details of the Cookies used by the Website are set out in Part 14, below; and
"Cookie Law"	means the relevant parts of the Privacy and Electronic Communications (EC Directive) Regulations 2003

# 2. Information About Us

## 3. What Does This Policy Cover?

This Privacy Policy applies only to your use of the Website. The Website may contain links to other websites. ### 4. What is Personal Data?

Personal data is defined by the General Data Protection Regulation (EU Regulation 2016/679) (the "GDPR") as 'any information relating to an identifiable person who can be directly or indirectly identified in particular by reference to an identifier'.

Personal data is, in simpler terms, any information about you that enables you to be identified. - **g)** The right to data portability. This means that, if you have provided personal data to us directly, we are using it with your consent or for the performance of a contract, and that data is processed using automated means, you can ask us for a copy of that personal data to re-use with another service or business in many cases.
- h) Rights relating to automated decision-making and profiling. We do not use your personal data in this way.

### 6. What Data Do We Collect?

Depending upon your use of the Website, we may collect some or all of the following personal and non-personal data (please also see Part 14 on our use of Cookies and similar technologies:

- IP address;
- Web browser type and version;
- Time zone setting;
- Browser plug in types;
- Operating system;
- Type of device used to access the Website;
- Location of access where using a mobile device;
- A list of URLs starting with a referring site, your activity on the Website, and the website you exit to;
- Become a Model Submission Form (Email, Name, Gender, D.O.B, Height, Age, Address, Social Media, Pictures), consent must be given for us to hold and process your data before it will let you submit the form.

### 7. How Do You Use My Personal Data?

Under the GDPR, we must always have a lawful basis for using personal data. This may be because the data is necessary for our performance of a contract with you, because you have consented to our use of your personal data, or because it is in our legitimate business interests to use it. Your personal data may be used for one of the following purposes:

- Providing and managing your access to the Website.
- Personalising and tailoring your experience on the Website;
- Supplying our services to you. Your personal details are required in order for us to enter into a contract with you.

- Personalising and tailoring our services for you.
- Communicating with you. This may include responding to emails or calls from you.

Please note that we do not control the activities of such third parties, nor the data that they collect and use themselves, and we advise you to check the privacy policies of any such third parties.

### 8. How Long Will You Keep My Personal Data?

We will not keep your personal data for any longer than is necessary in light of the reason(s) for which it was first collected.

We will only transfer your personal data to countries that the European Commission has deemed to provide an adequate level of personal data protection. More information is available from the <u>European</u> <u>Commission</u>.

## 9. Do You Share My Personal Data?

We will not share any of your personal data with any third parties for any purposes, subject to one important exception.

In some limited circumstances, we may be legally required to share certain personal data, which might include yours, if we are involved in legal proceedings or complying with legal obligations, a court order, or the instructions of a government authority.]

## 10. How Can I Access My Personal Data?

If you want to know what personal data we have about you, you can ask us for details of that personal data and for a copy of it (where any such personal data is held). This is known as a "subject access request".

There is not normally any charge for a subject access request. If your request is 'manifestly unfounded or excessive' (for example, if you make repetitive requests) a fee may be charged to cover our administrative costs in responding.

## 11. How Do You Use Cookies?

All Cookies used by and on the Website are used in accordance with current Cookie Law.

Before Cookies are placed on your computer or device, you will be shown a cookie notification requesting your consent to set those Cookies. The Website uses analytics services provided by Google. Website analytics refers to a set of tools used to collect and analyse anonymous usage information, enabling us to better understand how the Website is used. This, in turn, enables us to improve the Website and the services offered through it.

The analytics service(s) used by the Website use(s) Cookies to gather the required information. You do not have to allow us to use these Cookies, however whilst our use of them does not pose any risk to your privacy or your safe use of the Website, it does enable us to continually improve the Website,

making it a better and more useful experience for you.
